

OFFICIAL DALMATIAN ROAD TRIAL HORSE RENTAL/BOARDING/CAMPING FORM

Rental Fees: A check or money order is required by March 25th at 12 noon (PST). The rental horse is \$150 for RD for the event with a limit of 15 teams for the event. The Coaching Certificate rental horse is \$50 for the event with a limit of 8 teams for the event. There will be RDX rental horses available. All rental horses will be on a first come first serve bases. The RDX will consist of two rental horses \$000 for the event for the RDX with a limit of 3 RDX teams for the event. Please make check or money order payable to the Dalmatian Club of America for the entire amount of the rental horse or horses and mail with Horse Rental/Boarding/Camping Form to Teresa Bailey, 10727 Palm Row, Lakeside, CA 92040. No other means of payment will be accepted for rental or boarding or cowboy camping.

Boarding: Boarding of personal horses will be made available. A \$55 fee for the event per horse. Make checks payable to DCA and mail to Teresa Bailey, 10727 Palm Row, Lakeside, CA 92040. Boarding fees must arrive on or before March 25, 2008 at 12 noon (PST). Please note on check Road Trial Boarding. You must fill out a boarding form for each horse and mail to Teresa Bailey, 10727 Palm Row, Lakeside, CA 92040 The closing date for the Boarding/Rental/Camping form is March 25, 2008 at 12 noon (PST). This form must arrive by the closing date and time indicated to reserve your stall. Note: A current negative Coggins test less than 6 months(on date of arrival to stables) & health certificate less than 20 days old(on date of arrival to stables) is required for all horses, No Exception.

Camping: Cowboy or rustic camping will be provided. The fee for camping is \$35 for the event. Please note on check Road Trial Camping. You must fill out the form and mail to Teresa Bailey, 10727 Palm Row, Lakeside, CA 92040. The closing date for the Boarding/Rental/Camping form is March 25, 2008 at 12 noon (PST). This form must arrive by the closing date and time indicated to reserve your camping site. Make checks payable to The Dalmatian Club of America.

Rental Deposit and Boarding Fee Closing Date March 25, 2008 at 12 noon(PST).
